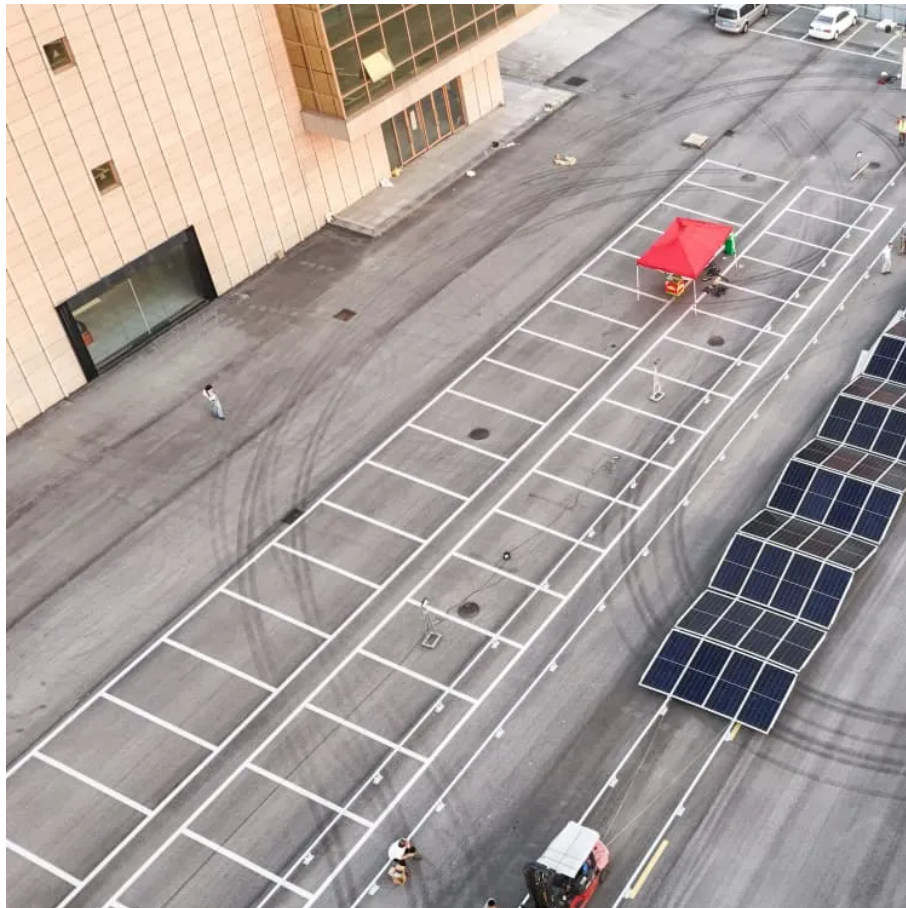

Why is bulk energy storage important?

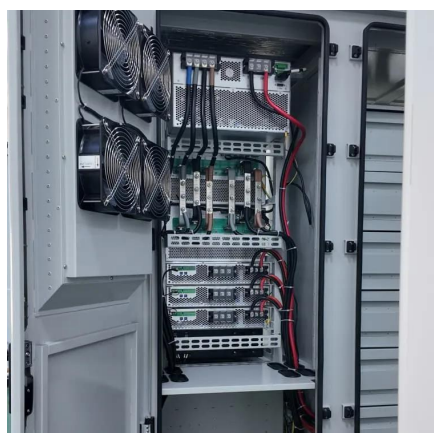
