

It is meant to provide a framework for those jurisdictions needing assistance in complying with Federal timeframes to act on Eligible Facilities Requests for modifications to existing wireless towers or base stations that do not substantially change the physical dimensions of such towers or base.

deployments. Comments will be due twenty days after publication in the Federal Register and replies comments are due ten days after the comment.

EFR under section 6409 of the Spectrum Act begins to run when the application is filed. 




### Wireless Facility Siting: Section 6409(a) Checklist




